Changes to CoCs announced



MinEx has been the industry lead on getting the much-awaited proposed changes to CoCs for the extractives sector from talk into action.

On Friday the WorkSafe Board announced three interim changes while the regs review winds its way through the tortuous process of Government/industry interface.

The three changes announced will be gazetted in June, and will facilitate:

- Site specific quarry managers qualifications
- Defining 'workings' of the relevant type of mine, tunnel or quarry
- First aid certificates – clarification of requirements.

Further changes to CoCs have been postponed until the review of the Health and Safety at Work (Mining Operations and Quarrying Operations) Regulations is completed, and the updated Regs are in place.

The Apprentice – you're hired

Donald Trump came to fame firing people as his apprentice. I'd much rather see our industry hiring people as apprentices.



It's not about getting one apprentice who triumphs but giving lots of (mostly) young people the chance to get a start in the extractive industry which has an average workforce age in the mid-50s.

I'm working with our industry training organisation, MITO to develop a programme which provides the right balance of on-the-job and off-site training. We've formed a group, the Extractive Industry Training Group (EITAG), to help bring this together. A particular spur is the fact that the new Government is providing one year of free fees for uni students but two years free for industry training (apprenticeships).

Meantime, we applaud the companies who are driving their own apprenticeship schemes, among them Ravensdown.

Getting down on dust

A major quarry expansion near Christchurch may signal that the debate over the impacts of dust is at least starting to moderate.

Road Metals has had approval, from Environment Canterbury (the regional council), for a 13 hectare expansion at its Yaldhurst site.



Approval is conditional on the silica dust monitoring programme in Yaldhurst, due to complete in June, not returning results above strict international standards.

I have been saying for months that the programme will not find any detectable levels of Respirable Crystalline Silica which was earlier the subject of some extravagant claims by residents and some authorities. If there is any RCS risk, it is to workers operating at very close quarters, not people 100m or more away.

This is not to say that there are no nuisance effects from poor management of dust issues on quarry sites.

If Road Metals does get its expected approval, it will have to meet the host of mitigation measures it has offered, including building high bunds around the site, keeping activities to at least 100m from properties, stopping activities on windy days, damping gravel with water and keeping to slow speeds to help avoid dust.

Fair enough.

Every quarry in the country can expect that such requirements will emerge as their consents come up for renewal – if not earlier.

Draft strategy on worker health and safety



The risks posed health for extractive workers will be among issues canvassed by MinEx in a submission to the recently released Government draft strategy for improving the health and safety of New Zealand workers over the next 10 years.

The Minister for Workplace Relations and Safety, Iain Lees-Galloway acknowledges New Zealand has made good progress in recent years

in reducing the rate of acute harm but wants to broaden the focus to make sure we're managing wider health risks, including mental health.

A key priority in the strategy is ensuring better outcomes for Māori and other workers at greater risk of being over represented in injury statistics and high-risk sectors, or more likely to be engaged in temporary, geographically remote or precarious employment.

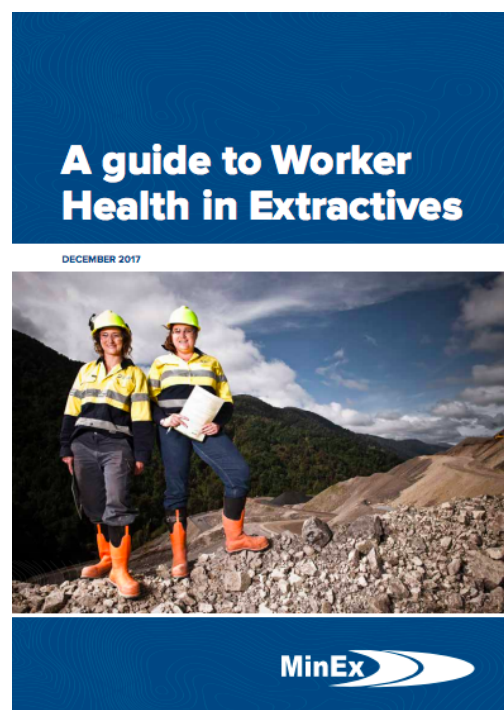

MinEx takes worker health issues very seriously. While the statistics may not be fully robust on worker death rates from workplace exposure (things like smoking complicate data) there is no doubt many more workers die of work-related illnesses than from injury at work.

Late last year MinEx produced a Guide to Worker Health available on our [website](#).

We are now working on a booklet on Slope Stability which we expect to roll out in July, followed by one on Mental Health, and another on Dust



Management.

I trust this confirms how importantly we view helping you and your staff towards our goal of no serious injuries or accidents in the extractives sector and their better health as well.
