Finally, training starts to move

Apprenticeships have been the poor cousin of training for too long.

Now things are really starting to gel. There's the Government's new fees free programme which means any qualifying trade trainee pays no fees across two years.

Earlier this month the Government announced the [Mana in Mahi - Strength in Work scheme](#) - designed to lift 18-24 year olds who've been on the dole into work that leads towards a Level 4 qualification. It will pay an employer the equivalent of a person's benefit, with the employer topping that up to at least the minimum wage. There's also extra funding of up to \$120 a week for pastoral care for the trainees.

Our sector is also recognising the fundamental need for training. The apprenticeship initiative I

Upgrade your CoC with Mines Rescue

If you would like to upgrade your CoC to a higher level, talk to Mines Rescue. From B to A Grade, A Grade to First Class Mine Manager, or you can add on specialist CoCs like Ventilation or Mechanical and Electrical if you have a trade background.



In many cases the upgrade from B Grade to A grade is only a small number of units.
