

## Get on board, we are rolling

This Train Brain rolls out from chilly Invercargill, where last week there was a warm welcome to the biggest-ever QuarryNZ conference, with no fewer than 630 delegates, partners and trade display people.

It's a whopping tribute to the ongoing growth of the extractive sector; we are all part of a rolling national success story - like the vintage trucks at the Transport World venue for the Gough Cat opening night dinner.

Infrastructure and Regional Development Minister Shane Jones reassured the conference just how important our industry is to the nation because nothing is built without extractives, along with a vow that he is our sector's champion in the Beehive. We will hold him to that.

Shane Jones also emphasised that for sectors like ours, training needs to be incentivised as a learn while you earn approach, even while some rationalisation is needed in the vocational sector. Big ups from me on that message.

Recently, I engaged Keri Harrison, one of our first mentors under the scheme we've established for the extractive industry, to do some mentoring for quarries in central/southern Hawkes Bay. In this Train Brain, read about how she got John Higgins through his B Grade oral exam on his third attempt.

I'm now engaging Keri to help the alluvial gold sector to develop a Code of Practice for Alluvial Gold Mining. MinEx and AQA have already helped Canterbury quarries develop a Code of Practice and I'm convinced that these codes will help lift health and safety outcomes as well as delivering improved environmental results.

Read also about IOQNZ's successes with its expanding professional development training having recruited former IOQ Australia chief executive Paul Sutton as Educational Officer. As Paul notes, this is only possible because of IOQNZ's collaboration with kindred organisations including MinEx, AQA and MITO.

Note too, how MITO is now further lifting its game with plans to add Level 4 qualifications from next month along with emerging micro-credentials that can see secondary school students put on a pathway to an extractive industry career. Expect to hear more on that shortly.

And don't forget there are still seven more MinEx workshops to run this year, starting in Invercargill on August 20 and 21. See details in this Train Brain.

# Keri provides the golden touch

Keri Harrison was one of the first to support the MinEx mentoring scheme and she's helped many others since - and she's really chuffed with her latest success.

MinEx funded Keri to travel up and spend a couple of days in Central Hawkes Bay, assisting Dave Olsen from Prenters and John Higgins from Barker Contractors.

John had previously twice failed his oral exam. Keri found John was a very experienced operator with all the technical knowledge but his confidence had been dented.

She visited his quarry site and worked with him and Dave over a day, using two pages of graphics



and refreshing their understanding of what oral exams required. On her return home to Canterbury, she followed up with a Skype meeting a couple of days before John's third oral exam attempt.

A text from his boss after the exam included a photo of John holding his B Grade CoC, followed by him sharing their delight with Keri by a Skype call.

"Out of everybody I've coached and taught, this would be the most satisfying. He knew all the answers - it was just a case of getting it out of him."

Keri acknowledges the support provided by MinEx and by Charlene Donald from WorkSafe.

Her next MinEx assignment is to go to the West Coast next month and work with alluvial gold miners to develop a Code of Practice framework document. May her golden touch continue.

# A house with many rooms



In a little over a year, Paul Sutton reckons he's helped lift IOQNZ so it now has over 1 in 5 of its 500+ members doing some form of professional development through IOQ programmes; by next year he wants 2 in 5 to have participated in IOQ programmes.

While his own experiences as an educator and then IOQ Australia CEO are useful, Paul is a great believer in collaboration; that a lot of material already exists for training if only you ask for it.

I was able to provide him with an Emergency Management PDP; he taps into some IOQ

Australia webinars; and he sees several 'rooms' collaborating within the home which provide the components for good training.

- MITO the industry qualifications room
- MinEx the room for H&S.
- AQA the advocacy room

- WorkSafe the regulatory room
- IOQNZ the room for training and CPD for the extractives sector.

Paul also provides some impressive follow-on services.

He will put all your formal and informal CPD learnings across the four required competencies into an Excel sheet for you.

"If you don't have the time in your busy lives, I'd prefer you do the CPD rather than the administration."

And when you do some training with him, he always follows up with an email the next day and subsequent days if unanswered. He says checking on what people have actually learned from a webinar helps ensure the training remains relevant.

## Mental health intervention after webinar

One of Paul Sutton's webinars, dealing with mental health, saw an inspiring story shared at the QuarryNZ Conference.

Isaacs Construction quarry manager Adam Waite did the webinar and provided his workers with Paul's mental health self-assessment tool at the pre-start the following day; any use was voluntary.



An hour later one of his staff asked to talk; he'd filled in the self-assessment and worked out he was depressed. Adam asked what was up and the worker opened up about his unhappy personal life. Adam organised for him to see a counsellor and the worker is now in a much better place. "I keep checking on him but he's pretty good so far."

Paul says he knows sometimes CPD can look 'bloody annoying' but you need to think about the outcome for that worker if he didn't have the tools to assess his mental state.
